Release and Waiver of Liability and Assumption of Risk

I hereby agree to assume these risks, for my children, guests, property dog and myself.

I agree that it is solely my responsibility to determine whether the dog park property itself and any particular situation involving other members, guests and dogs is safe for my children, guests, property, dog and myself.

In exchange for the opportunity to use Bree's Bark Park according to the Rules, I hereby release, discharge and hold harmless Community Animal Rescue and Adoption (CARA) and its representatives, officers, board members, employees, and agents from any and all liability, claims, demands, causes of action, or any other legal cause arising out of or related to loss or damage or injury to person or property, including any death or serious injury which may result while my children, guests, dog and myself are at Bree's Bark Park and on CARA's premises.

I agree to be responsible for my children, guests, dogs and for any liability caused by my children, guests, property, dog or myself.

I further agree to hold harmless and indemnify CARA and its representatives, officers, board members, employees, and agents for any claims, causes of action, lawsuits or judgments against any of the foregoing entities or persons that are asserted because of any action or inaction of my children, guests, dog and myself. This indemnification shall include court costs and attorney fees and costs, including costs of appeal.

I have read, understand, and agree to abide by all of the Bree's Bark Park at CARA Rules and the Indemnity Agreement, Release and Waiver of Liability and Assumption of Risk. I understand that CARA reserves the right to alter or amend its rules at any time. I intend for this release to be binding upon my heirs, beneficiaries, next of kin, personal representative or executor and assignees.
